## Miami **Prosecutor** Charged With Racial Bias

MIAMI, FLORIDA - NB-NS - A team of 25 to 35 Federal prosecutors and agents have arrived here to look into alleged civil rights abuse by local law enforcement officers.

Attorney General Benjamin Civiletti heads the team, which will inquire not only into the case that triggered the spontaneous rebellion by the city's Blacks a week ago. but also several other instances of alleged police abuse against Black Miamians.

A grand jury has already begun hearing evidence against the four white former officers to

determine whether they will be charged with civil rights violations in the beating death of Arthur McDuffie, a 33 year old Black insurance executive.

The anger among Miami Blacks is now focusing on State's Attorney Janet Reno. Comspokespersons blame Reno for the acquittal of the four officers after the state ioined . in prosecution.

Calls for her resignation head the lists of demands made by Black leaders. The 41 year old Harvard Law School graduate was

asked to step down by the National Association for the Advancement of Colored People, of which she is a member. Mayor Maurice Ferre said she ought to step aside until charges that prosecution was biased in the case that touched off the violence has been resolved.

The State's Attorney's position, filled by countywide election, is one of the few exercising jurisdiction over the entire Dade County. With Black support, Reno came to office a little over two years


