Johnson Tries Dewar

Earvin "Magic" Johnson of the world champion Los Angeles Lakers and Baseball Hall of Famer Hank Greenberg will be in Las Vegas for the 10th annual Dewar's sports celebrity tennis championship June 16-19 at the Riviera Hotel courts.

Other basketball greats to join "Magic" will include Julius "Dr. J." Erving, Philadelphia 76ers; Bob Lanier, Milwaukee Bucks; Paul Westphal, Phoenix Suns and another basketball great Earl "The Pearl" Monroe in this mixed partners, doubles competition.

Even more amazing than the basketball talent in the Dewar's is the magnificent tennis machine still purring at the age 69, Hank Greenberg.

"We could field a darn good basketball all-star team from among the players in the Dewar's," said tournament chairman Iz Becker.

Of the nine previous tournaments, Greenberg has won six, one at singles and five at doubles. He has won the doubles competition with partners ranging from former USC basketball coach Bob Boyd to Houston Rockets superstar Rick Barry.

Lopez Pursues Crown

The date has been set for the June 21 World Boxing Council's featherweight championship title fight against the champion Salvador Sanchez and Danny "Little Red" Lopez at Caesars Palace.

Sanchez won the title from Lopez on Feb. 2, in a 13th round TKO in Phoenix.

The card will be televised by ABC. Also on the card will be bantamweight Alberto Davila, (No. 1 in both WBC and the World Boxing Association), bantamweights Jaime Garza and Oscar Muniz, plus heavyweight Franco Thomas.




replied. "It was a draw and a point of order was established between the two."

that Lou Tabat is there.

The best reflection of Lou's civic leadership is the fact that he and his deputies donate their services as security officers to every telethon, walkathon, and marathon, charitable type organization that comes to Clark County. When Tabat first took office he made it known to organizations such as Easter Seals, Heart Fund, MDA, etc., that he would donate the security officers needed for their functions here. They accepted gratefully.

Today Lou and his men provide the services to all such functions. Tabat and his cadre of 20 smartly

uniformed NLV Constables have donated 6400 manhours. "We are the only such volunteer group around. Every year the requests increase," says Lou. As to the men who donate their time, Tabat says, "These guys are the greatest! They give themselves."
