# Veterans Questions Answered

discharge for treatment of service incurred dental conditions;

--veterans with non-compensable service connected dental conditions caused by trauma;

--those with service connected medical conditions which are professionally determined by the VA to be aggravated by a dental condition;

--certain veterans in VA rehabilitation programs; and

--veterans of conflicts prior to World War I whose dental conditions are presumed to have been service connected.

If you have been receiving Veterans Administration educational benefits checks and are moving at the end of the semester, you should leave your forwarding address and notify the VA.

At least 14,000 G.I. Bill students filed changes of address with VA last month to help insure that their checks follow them

wherever they go this summer. But many fail to notify the agency after a move, and these are the ones VA Administrator Max Cleland worries about.

"For example, if the semester ends in May, the student may leave campus before his check arrives," the VA chief said.

"A late check can mean problems to a veteran student's budget," Cleland said. "The risk of missing a check can be avoided with a change of address notice."

Some 650,000 veterans were expected to receive education checks in May. According to Cleland, VA takes pride in its overall record of getting benefits to the right person, at the right time, at the right place.

Changes of address can be reported to veterans representatives on campus or to the local VA office in addition to the U.S. Postal Service.

**Q - I am a Veterans Administration work-study program student but I am being forced to withdraw from all my classes. May I work out the remaining hours of my contract?**

**A - Yes.** You can work out those hours of unperformed service for which you received advanced payments.

**Q - How much will the Veterans Administration pay for a tutor for students receiving VA educational benefits?**

**A - The monthly maximum is now \$69 with an overall maximum of \$828.** Tutorial assistance does not affect basic educational benefits entitlement.

**Q - Under the Veterans Administration Dependents Educational Assistance Program, may the child of a permanently and totally service disabled veteran take on-the-job training or enroll in a correspondence course?**

**A - VA will pay for on-the-job training for eligible dependents in this category, but there are no provisions for paying for their correspondence course.**

**Q - I am currently receiving VA dependency and indemnity compensation as a widow. I plan to enter a program of education soon. Will the education assistance I receive affect the DIC benefits I now receive?**

**A - No.** Education benefits will not affect the payment of DIC to a surviving eligible spouse.

**Q - How do I apply for VA educational benefits to attend college?**

**A - Complete VA Form 22-1990 with a certified copy of your DD Form 214 at the nearest VA regional office.** You may submit this application as much as 120 days before classes begin but not less than 30 days before classes begin.

**Q - What is the new interest rate on Veterans Administration guaranteed home loans?**

**A - The maximum rate for VA as well as FHA loans is 14 percent as of April 13, 1980.** Because the rate goes up and down with changes in the "money market," you should check with a lender or local VA office at the time you plan to buy.
