Governor Robert List today set in motion the Governor's Management Task Froce which will undertake a cost-cutting review of state government.

List announced that the goal of \$220,000 had been pledged by private industry and that twenty-four "loaned executives" were standing

by, ready to begin work on the project.

"Private industry has responded enthusiastically to this program," said List. "We will have the full amount of pledged funds and manpower that we solicited. This is a strong statement of business support for this unique partnership between public and private

"The twenty-four key executives assisting in the study are top level in their fields," List added. "We are looking to their expertise and their outside professional perspective applied to state government to help us keep costs down while providing services at equal or better levels."

List welcomed the executives and thanked private business for its generous support of

the program.

Attending the kick-off meeting were department heads and managers of state department heads and managers of state department. ments involved in the review, the nine member Task Force Executive Committee, and the twenty-four "loaned executives" who will conduct the study.

Task Force executives have been divided into three teams to conduct the twelve-week review, which will concern itself with central services, human services and commerce and transportation.

Warren King and Associates, a Chicago-based consulting firm, has been retained by the Task Force to oversee the study. The firm has successfully completed thirty-one studies in twenty-seven states.

Berlyn Miller, President of Acme Electric and past president of the Greater Las Vegas Chamber of Commerce, will chair the Task

List said that in these times of inflation and recession, increased productivity was necessary to realized the full benefit from every tax dollar.

The Task Force was created by List in May to help stabilize or reduce the increasing cost of state government and to streamline state government operations and improve

Findings of the Task Force will be made public in a report this December.

## Las Vegas BLM Sells Land

A 2.5 - acre parcel of public land was sold June 18 to Warner Meese of Los Angeles during the Bureau of Land Management's monthly offering of parcels in Las Vegas Valley.

Meese paid \$77,500 for the tract, located along the Union Pacific Railroad's right of way south of Tropicana Ave. The area is generally considered for light industrial or compensation.

way south of Tropicana Ave. The area is generally considered for light industrial or commercial use by Clark County planners.

The parcel is one of several left from a 1978-79 land auction conducted by the agency in Las Vegas. The 12 tracts that remain unsold-ranging in value from \$53,000 to \$130,000 will be reoffered to the public at 10 a.m. July 16 in the bureau's Las Vegas office.

### Grievance Filed On School

The Clark County Classroom Teachers Association on Tuesday filed a grievance against the Clark County School Trustees and Superintendent Claude Perkins for their June 12 action to eliminate junior varsity sports. "The abolishment of the junior varsity sports program is a violation of the contract between the association and the school district."

between the association and the school district, said CCCTA President Ouida Brown.

Brown noted that the board and Perkins had been notified that the association would consider the cutting of junior varsity sports as a contract violation.

Elimination of the sports program violated Article XXVII of the the 1979-81 contract, which provides the extra pay for extra duty schedule for teachers who work additional act-

ivities such as coaching.
"All coaching salaries were part of the teachers' money package during the last two bargaining rounds between the association and the district," said Brown. "All funds appropriated therein were teacher controlled

As such, the negotiations team for the CCCTA assigned portions of the funding to the extra duty schedule, making it part of the contract.

"Teachers have to abide by the contract and the district must do so also," said Brown. "We have no alternative but to file a grievance on behalf of the teachers and coaches of this district."

Brown expressed concern that the board's action, based upon Perkin's recommendations would cause teachers to feel distrust of good faith negotiations on the part of the district in the future.

'If the trustees are going to cause the district to violate the contract, which their repre-sentatives negotiated with their consent and approval, then we certainly cannot feel they will negotiate in good faith next January, when negotiations again resume for the 1981-82 school year contract."
