Recent negotiations with the Bank America organization resulted in the engagement of MD&Co. The firm will provide a number of auditing services including the annual opinion audit of BA Cheque Corporation, a whollyowned subsidiary, and participation with Bank-America's principal auditors, Ernst & Whin-ney, in the review of selected California branches of the bank. 
