

Charges Of Discrimination Filed



Mr. Edward Quijado recently filed charges of discrimination with the Nevada Equal Rights Commission and the Office of the Federal Equal Employment Opportunity Commission

in regards to alleged discriminatory hiring practices of the Clark County Juvenile Court Services.

Mr. Quijado alleges that on or about 27 June 1980, he and others did submit to an oral interview as part of the employment procedures of the Clark County Juvenile Court Services. Mr. Quijado was selected as the top applicant for the position of Youth Counselor I. Unexplainably, Mr. Quijado was denied the position and was informed that he must submit to reexamination.

Mr. Quijado feels that this denial of employment and the requirement to submit to reexamination is a violation of his equal employment rights.

Pursuant to the Civil Rights Act of 1964, and as amended in 1972, Mr. Quijado feels that it is sad and tragic that he must take this means to secure for himself that which is mandated by law, but that this untoward action must not go unchallenged.

Complaints will also be filed on Mr. Quijado's behalf with the Office of Health, Education, and Welfare, and the Office of Revenue Sharing.
