## **NAACP FILES** FOR DEFAULT **JUDGMENT**

The Western Regional Office of the NAACP announced today that the attorneys representing the estate of Mr. Charles James ("Poppa Charlie") have illed a motion for a default judgment against the City and County of San Francisco and those police officers who were involved in Mr. James' violent death. Mr. James, a disabled Black senior citizen, was killed by a barrage of police weapon fire after

an early morning intrusion into his Hunter's
Point residence in July of 1978.

The Civil Rights and Vrongful Death complaint was filed in federal court in September of 1979. The defendant police officers and the City and County of San Francisco have failed to answer this complaint in spite of the fact that plaintiffs extended the time for answering to February 4, 1980. As a result of this failure to answer or othervise respond, the attorneys for the estate of Mr. James have filed this current motion so that the Court can enter judgment for plaintiffs.

A hearing for the Motion for Entry of the Default Judgment has been scheduled for August 4, 1980, at 10:00 a.m. before the Honorable Robert F. Peckham in the United States District Court for the Northern District of

## **LACERATION** HAZARD!

Sears, Roebuck and Co. today announced a plan to correct a possible problem on 55,000 ten-inch motorized miter saws which could pose a laceration hazard when used with carbide-tipped blades, Under certain conditions, the blade could come off and, while still spinning, strike the user.

The company said it has received reports of three such incidents, with one resulting in a serious facial injury. The problem results from the fact the carbide-tipped blades are thicker than regular original equipment blades are most often used on soft metals. Sears cautioned consumers using the carbidetipped blades to stop doing so immediately.

The voluntary corrective action applies only to two models of Sears saws which sold for approximately \$200 under the name Craftsman motorized miter saw. The models have ten-inch blades ad were sold between July 1978 and June 1980. The model number on the affected units, which are located on a plate on the end of the motor, are 315.23730 and 315.23731.

Consumers who have miter saws with either of these numbers should contact their local Sears store or call toll-free to 800-845-4781 to arrange for a free correction

challenge of helping to build the museum by making available staff experts to work on the feasibility study and other p. eliminary activi-



A national conference is being planned for 1981 to bring together individuals and organizations which will have an active interest in the development of the museum.
