Foxx's Wife Loses High Court Appeal

Yun Chi Foxx, whose marriage with entertainer Redd Foxx "fell on the rocks," lost last Friday in the Nevada Supreme Court bid to block Foxx from Judge-shopping" for a divorce trial in Las Vegas.

Represented by Los Angeles lawyer Marvin Mitchelson, she told the high court that she would suffer "inconvenience, hardship, vexatiousness and oppression" if the trial was held in Las Vegas.

Foxx filed for divorce in Clark County District Court in October 1979. A few days later, Yun Chi Foxx filed an identical action in Los Angeles Superior Court.

Yun Chi then sought to block the Nevada

proceedings, but Clark County District Court Judge Joseph Pavlikowski refused to drop the case.

The Supreme Court, said Pavlikowski, has jurisdiction over the matter and "we do not find our intervention at this time... to be warranted."

Mitchelson had contended that all records and witnesses in the action were in California. He said there's a question over Foxx's actual residence. He said the entertainer has stated he spent time in Las Vegas but "not for the purpose of establishing a home there." Mitchelson said the statement was made previously under oath by Foxx.

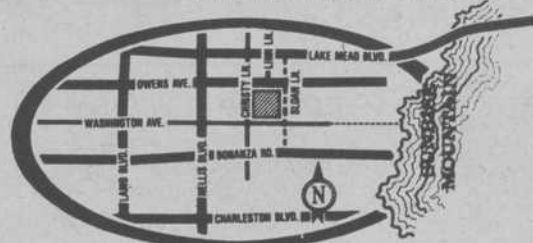
