"Of course not" was Hoggard's response as he went on to report that the funding for EOB for Clark County would not be affected by the national economic slowdown and the pending federal budget cuts of social programs.

During the interview, Hoggard said the agency received a major portion of its yearly federal funding from the Community Services Administration and indicated that the EOB operated on an estimated \$5 million yearly budget.

About \$400,000 comes from the CSA, and the rest from the State, Clark County, private donations and from several other agencies.

EOB attempts to alleviate the causes and resulting conditions of poverty to more than 40,000 in the County.

"The Economic Opportunity Board offers its services mainly through public, tax-supported dollars that are intended to enable low income families and individuals to secure opportunities to become self-sufficient," says Barbara Brady, EOB Chairperson."

"The work done by this agency is a combined effort of many throughout the community. Its policies are established by a volunteer board of directors," she continued.

"The staff, consisting of nearly 200 individuals, is responsible for making sure these policies are carried out and to serve those people who are qualified and need our assistan-
