the group disavowed its support of Bauman. But not Falwell. He offered "forgiveness and prayer" on the grounds that since he didn't call for the resignation of Sen. Edward M. Kennedy after the Chapquiddick incident, it would be inconsistent for him to ask for Bauman's resignation.

Falwell thus proves that he is not God's messenger of greater moralism; he is just another right wing political polemicist.

My instincts always have been to show some compassion to those afflicted with alcoholism or sexual problems. My compassion runs thinner than the watered scotch in a ghetto gyp joint now that every congressman caught taking a bribe or otherwise violating the law cries, "I was drunk!"

I have absolutely no sympathy for Bauman. His personal physician has said that the congressman is "in no way, shape or form an alcoholic," leading me to believe that Demon Rum had nothing to do with Bauman's search for prey in the world of homosexuals.

What really destroys Bauman's claim to your or my sympathy is the

mean hypocrisy of the man. A year ago he voted to block House consideration of a \$221 million alcohol abuse program. He voted to deny federally financed legal assistance to homosexuals. He has consistently fought efforts to extend federal civil rights protection to gay people. He has been the super-moral advocate of a "family protection act," and has become a darling of the anti-abortion forces.

While Bauman was ranting about the "right to life" of fetuses, he didn't tell us that 16 year old boys have the right to a life secure from his homosexual blandishments.

Whether you're 16 or 60, if you see a Falwell and a Bauman approaching you with a banner proclaiming their super morality, you had better run like hell — away from them.

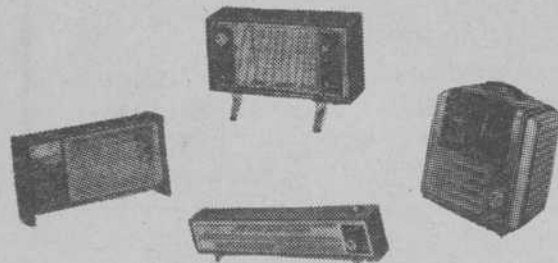
