

## NEVADANS SAY OFFICIALS NOT SUPPORTING MX

N.O. MX — Nevadans Opposed to the MX missile system — believe that local officials are not helping Clark County by welcoming the nearby location of the main base of the MX system. Las Vegas is already suffering from housing and traffic problems, increasing air pollution and population growth that is pressing upon county resources.

"The base will create competition for labor, building materials (esp. cement), transportation, electric power, gas, water, school facilities,

and social services," says Stephen C. Rohl, Public Affairs Director for the Southern Nevada Chapter. "We feel that this is of particular concern to those on fixed incomes. Far more people will come to Las Vegas than will get jobs. These people will require schools and social services at a time when the State of Nevada is moving toward a reduced budget.

"Since the base will be a Federal Government installation revenue that can be taxed by state and local

Brown says the VOICE will resume publication on Dec. 17 after a period of several months idleness. The paper will be published each Wednesday and will be available through the news racks located throughout the Las

Vegas area.

The VOICE offices and printing facilities are now located at 314 E. Lake Mead.

"Lee Walker has been appointed Advertising Manager," Brown said. "We have also added Robert Foster as Director of Composition, Laurie Stokien as Office Manager, Emmett Davis as Graphics Director and Rev. Sam Roberson as the Religious Editor."

The basic format for the VOICE will be a concerted thrust on repor-
