LAS VEGAS CONVENTION AND VISITORS AUTHORITY EXECUTIVE DIRECTOR

The Las Vegas Convention/Visitors Authority (LVCVA) is a multifaceted convention and events complex, consisting of a 785,000 sq. ft. convention facility with an added 222,000 sq. ft. of meeting rooms and exhibit space under construction. Other facilities include the 31,000 seat Silver Bowl Stadium, and soon to be added downtown complex, with a 15,000 seat sports stadium, 2300 seat fine arts/performing arts center and a 100,000 sq. ft. convention center. These facilities accommodate a variety of conventions, trade shows, sports, cultural and civic events. The projected budget for the next fiscal year stands at over \$20 million.

The successful candidate will have demonstrated effectiveness in an executive administrative capacity; along with a proven record of accomplishment in the promotion of convention sales, cultural events, travel/tourism or closely

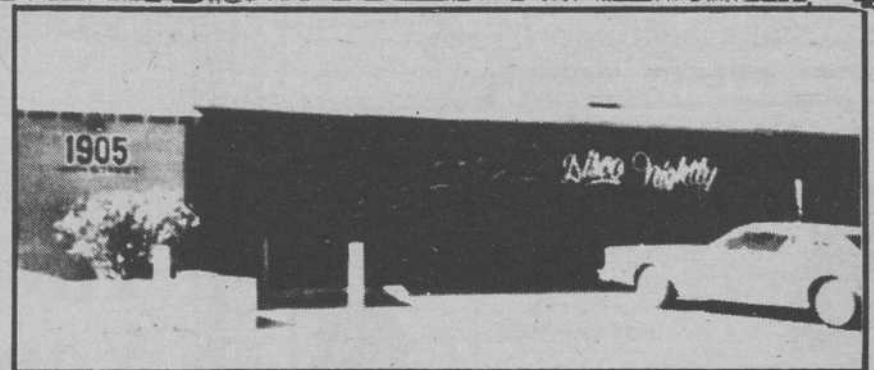
