HUMAN RIGHTS

The Nevada Equal Rights Commission recently conducted a preliminary investigation into an alleged unlawful practice in housing in northern Nevada. The Commission determined that the practice would cause irreparable harm to the aggrieved person. Pam Bugge, the Deputy Attorney General for the commission, sought and was issued, a temporary restraining order - pending a hearing. After hearing and reviewing all the facts presented, DistrictJudgeGabrielli granted a 60-day injunction. The Commission's investigation resulted in a final determination of probable cause. The case was subsequently settled through conciliation.
