IRS Undercover Investigation Produces Indictment of Investment Counselor Running Tax Shelter Programs

United States Attorney Andrea Sheridan Ordin announced late Wednesday that a federal grand jury has returned indictments against Garrison M. Everett III, whose true name is George Monroe Eggleston. President of Intervest Associates, Inc., a resident of Newport Beach, California, and Intervest Associates, Inc., a firm headed by Mr. Everett for conspiring to impede, obstruct or interfere with the administration of the Internal Revenue laws. The indictment resulted from an IRS undercover operation investigating tax shelter operations.

The indictment charges that the conspirators provided an undercover IRS agent with documents backdated to December, 1980, allegedly showing transactions completed in 1980 which the government alleges were not even begun until March, 1981.

The indictment further charges that the undercover IRS agent, posing as an agent for a wealthy investor, met with Everett and Richard I. Chira, an undicted co-conspirator, on several occasions in April 1981, to discuss the development of a tax plan for the agent's wealthy client.

The indictment alleges that during one of the April 1981 meetings, Everette told the agent that he was able to put together two packages to be used to shelter 1980 taxable income. Everett gave the undercover agent documentation for an office furniture package and computer package.

Assistant United States Attorney, Rick M. Flam, who coordinated the investigation a presentation of the case to the grand jury, stated that the investigation culminated on April 16, 1981 with the arrest of Everett and others following a meeting with the undercover agent during which everett and other conspirators signed the backdated documents.

If convicted ,Mr. Eggleston, and the coporation, Intervest, could receive a fine of up to \$10,000 and prison terms of five years. An indictment is merely a charge and the defendants are entitled to a fair trial at which it will be the government's burden to prove guilty beyond a reasonable doubt.

Child Find Project Remains Open During Summer Months

The Clark County School District's Child Find Project will be in operation during the summer months to provide free diagnostic and placement services to children in need of special programs next fall. The Child Find Project is mandated by Federal Law to locate, identify and evaluate any suspected handicapped individual, age 0-21, who is not being served through public education.


This summer, the Child Find diagnostic team will include a psychologist, nurse, social worker, speech therapist and

New Silver Half Dollar

WASHINGTON (AP) -The House of Representatives voted Tuesday to authorize the minting of a new 90percent silver half dollar and to price the collectorsitem coin at between \$9 and \$12 to help reduce the national debt.

The 50-cent coin would bear the likeness of George Washington and would be sold in 1982 and 1983 to commemorate the 250th anniversary of his birth.

It would be the first new U.S. coin since the government's unsuccessful experiment with the Susan B. Anthony dollar coin in 1979.



educational specialist to provide their specxific expertise, whe appropriate, in the diagnostic process.

Any child who demonstrates significant development delays, learning problems, hearing or vision deficits, physical or speech probelms so that he/she cannot function educationally without a special program, is eligible for an evaluation.

Early identification of developmental, emotional and learning problems has been found very important in helping children overcome or compensate for these difficulties. Clark County School District provides programs for infants that are hearing or visually impaired. Preschool programs are available for these children as well as children with developmental delays at ages 3 and 4. Special educatrion programs are available to all school age children from ages 5-18 according toi their individual needs. A post secondary counselor is available to help individuals from 18-21 to find appropriate training and/or job opportunities.

If parents of a child who was not enrolled in Clark County Schhol District during the 1980-81 school year suspect that their child may have a handicapping condition, they should contact June Baker. Consultant, Child Find Project, at 385-5070. Children new to the District or children who attended private schools are also eligible for an euvaluation.
