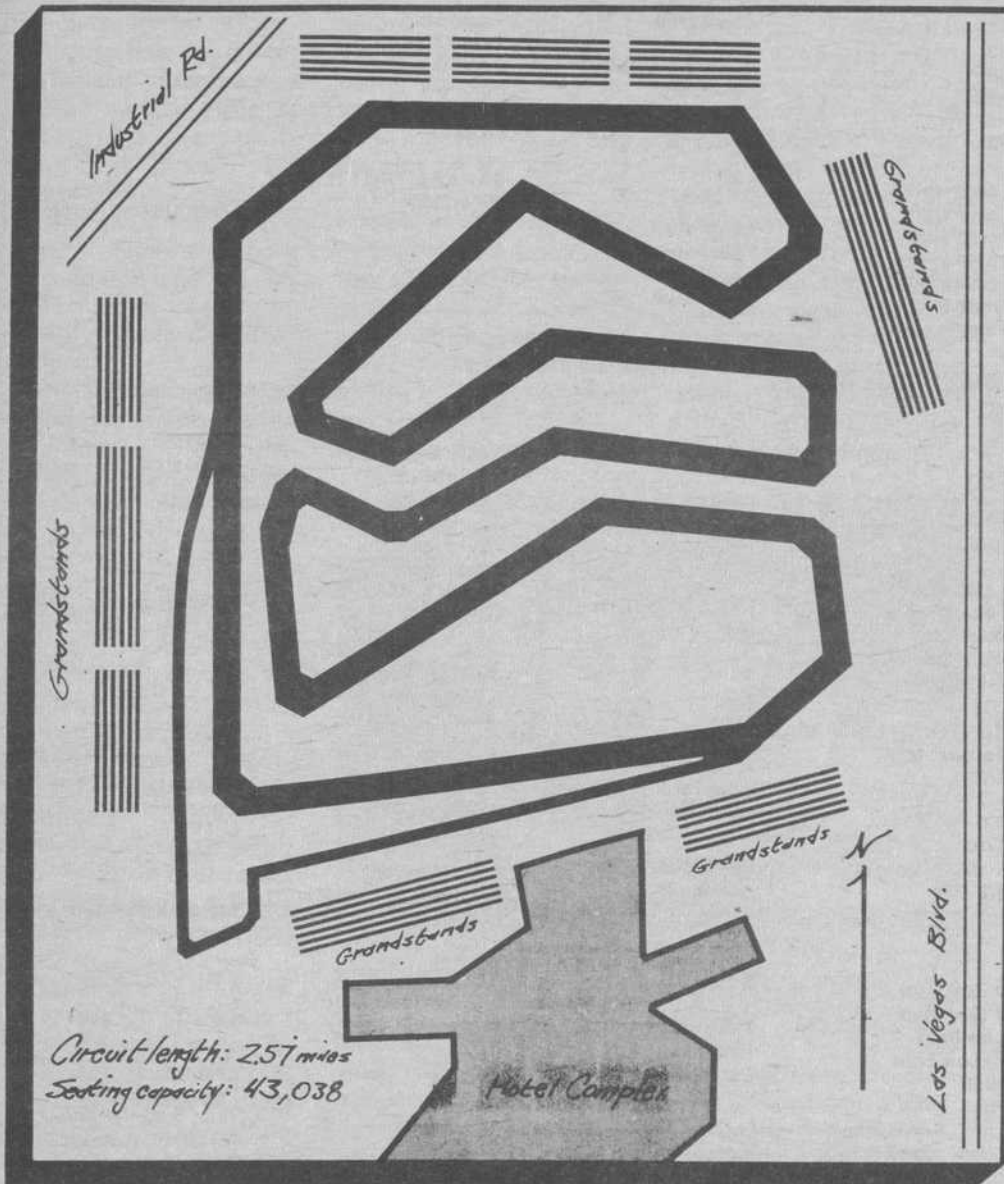
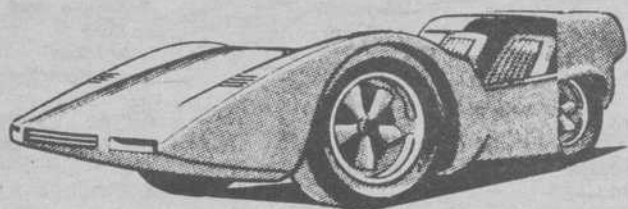

Leonard-Hearns Bout Signaled

Emmanuel Steward, trainer for Thomas Hearns, World Boxing Association's welterweight champion, said last week, "If I were a betting man, I would put my money on the fight taking place in Las Vegas."

Hearns, who wants to wear the welterweight crown of Sugar Ray Leonard, World Boxing Council's titleholder, came to Leonard's backyard meeting with congressman and the media on Capitol Hill.

Hearns was in Las Vegas Tuesday to participate in the television candid new show "Weekend Heroes" co-hosted by Jayne Kennedy and Paul Hornung.

Don Chargin Takes Over Showboat Boxing Cards

Don Chargin's Azteca Promotions, Inc., presents its first in a series of regularly scheduled fight cards at the Showboat Hotel, Casino and Bowling Center Friday, June 19, beginning at 8 p.m.

The card, entitled "Undefeated Champions of the Future," features three 10-round bouts plus two four-rounders.

The main attractions include lightweight Tony "The Tiger" Baltazar against Las Vegas Manny Lopez, super bantamweight Jamie Garza against Carlos Zuniga and featherweight Rocky Garcia against Javier Flores.

The card will be held in the Showboat Sports Pavilion. Doors open at 7 p.m. There'll be three ticket prices—\$15 for ringside reserved, \$10 for preferred and \$5 for general admission.

The fights will be televised live to more than 8 million persons across the nation by the USA Cable Network. USC and San Diego

Chargers announcer Tom Kelly and Los Angeles Herald-Examiner sports editor Alan Malamud will do commentary.

Baltazar, 20, Garza, 21, and Garcia, 23, are the three undefeated youngsters on the card. Baltazar has a 15-0 record with 12 knockouts, Garza is 26-0 with 24 knockouts and Garcia is 22-0 with 19 knockouts.

All three are from Los Angeles.

This will be the first time Baltazar has fought outside of the Olympic Auditorium in Los Angeles. He has had two fights this year; on April 30 he decisioned Darrel Stovall and on March 19 he stopped Raul Bercoma in the fifth round. Baltazar was out of action from October of last year until this March after cutting his right hand and undergoing plastic surgery to repair the damage.

Garza, who's going for his 11th straight knockout at the Showboat, has fought

three times this year but for a grand total of only four rounds. He stopped Alejandro Garcia in the second on May 15, Hector Cortez in the first on April 4 and Robert Anderson in the first on Feb. 17. All three bouts were in Los Angeles.

Garcia's only fight of this year came at the Showboat on May 30, underneath Azteca's championship bout in which Cornelius Boza-Edwards successfully defended his World Boxing Council (WBC) super featherweight title against Bobby Chacon. Garcia, coming back from an illness which kept him sidelined from November to May, stopped Tony Sanchez in the second.

Flores, from Salt Lake City, enters with a 29-8-3 record. Zuniga is from Stockton, Calif.

Tickets can be purchased at the Showboat Sports Pavilion ticket office prior to the fight or at the door Friday night.

WATCH THOSE ADDITIONS!

How much thought did you give to that new patio, redwood deck or room addition that you may have added to your home? In most cases, plenty! What you may not realize is that even before the project is started you should notify your insurance agent in order to avoid falling into what is known as the "homeowner's coverage insurance gap."

All too often a policyholder may put a \$5,000 or \$6,000 addition onto his home but not tell his insurance agent. The oversight can be costly in two ways. First, if the home is partially or totally destroyed by fire, it may not be covered for the full loss.

Secondly, if the home is not insured for at least 80 percent of its replacement value, the policyholder will lose out on a special feature included in the homeowner's policy. Subject to individual policy limits, losses are covered for full replacement cost (as opposed to a depreciated value) when the amount of insurance on the home is kept at or above the 80 percent level.
