"The only measurement for Joe is that he did do his job. He did not achieve greatness because of the presence of money, and his worth is not altered in the absence of money. It is vulgar to speak of Joe Louis and money as if money was the balancing act in his contribution. We must not succomb to the value system that forces us to measure the worth of people by a balance sheet. Such a gift as Joe must be measured in kind. Jesus died penniless, with nails in his hands, yet he had all power in those hands. Thank God, that because of Martha, Frank and friends, Joe Louis lived above want. Joe had the best of medical care, a comfortable home, more invitations to travel around the world than he could ever honor, more clothes than he could ever wear. Money appears to be the Achiles Heel in the eye of many writers. But, Joe - like Jesus - was not a bargain; he was a gift. People with money felt lucky to be able to share it with Joe. His wealth did not fluctuate with the stock market."

"When the word came across the news that Joe was dead, my mother, nearly 60 years old, said, 'Lord, Have Mercy. We've lost our hero...You and all the boys up the street have his name.' After five minutes my Grandmother, nearing 80 years of age, said, 'We have lost all we had. We loved Joe.'"

"When Mount St. Joe erupted, some ashes fell on everyone. We do not identify with the 'Poor Old Joe' stories. His name is wonderful! When Joe fought something inside said 'We ought to be free!', and something on the outside said, 'We can be free'. Joe Louis, we love your name. To the host of witnesses gathered here, you tell the story. Let them run extra editions of the paper as they once did. Tell the people that Joe is still in the center of the ring without a challenger or a peer. Extra! Extra! Tell them Joe is too high for his critics to reach him now. You've reached another plateau. It's alright now. They can hit the street with the next edition now...Joe Louis, the pearl of the Black race; the treasure of the Human race...Our Joe wasn't dumb - he was generous...Dumb people get tricked out of their integrity. Dumb people steal, throw fights and other things that bring shame on themselves...Joe Louis, he fought a good fight, finished his course - he kept the faith. Now, he belongs to the Ages.

WRITE END:—Melba Moore is something else again, as is the entire cast, of "Innocent Black." It's a show which does something laughable with your funny bone and stimulates your imagination about, and pride in, the black experience beyond the ghetto. The ofays did not understand neary a'word so the critics pulled their write hand from under it. Hope is that it will remain on the stem long enough for the black rally that will keep it open. Go see it, you hear —STAY LOOSE.
