SECOND TRIAL

For the second time, Rev.' Albert Dunn, pastor of Allen Chapel A.M.E. Church and long time civil rights activist, is scheduled to go on trial for conspiracy in a counterfeiting ring.

DUNN TO RECEIVE

The trial, which is to take place on August 11, will again be heard before U.S. District Judge Harry Claiborne. Assistant U.S. Attorney Ruth -Cohen will again prosecute the case.

In connection with a million coun-\$10 terfeiting operation which was uncovered by the Secret Service, Dunn was tried for but acquitted of counterfeiting charges. However, the jury convicted him of conspiracy.

After Rev. Dunn had served more than seven months of his 3 year sentence, the U.S. Circuit Court of Appeals overturned that conviction, because the government had failed to cooroborate the testimony of a codefendant, who had been granted immunity and testified against Dunn. The appellate court called the prosecution's case "extremely thin."

Rev. Dunn's defense attorney Tom Pitaro succeeded in getting a new trial ordered for Dunn. However, Attorney Cal Potter has been appointed to represent him during the forthcoming trial.
