weapons which are being used to annihilate Blacks.

While the issue in South Africa is not religion, but color, still the destructive weaponry furnished by Israel to South Africa is just as deadly.

In light of the above, Greenspun's apprehension concerning the United Nation's support of Israel is understandable. But as far as Black Africa is concerned, its condemnation of Israel is not reflective of Israel's right to exist as a nation, but of her policies of furnishing weapons of destruction to an Aparthied country which supporesses Black Africans.

Is Israel's right to exist greater than that of the children of Swete or Sharpeville, South Africa. I think not!

Life is just as important to the Blacks in South Africa who are being killed by weapons furnished by the Israelis, as it is to those being killed in Israel by the Palestinians with weapons being furnished by France, Italy or Libya.
