

Federal social programs should meet clear criteria: They should be national in scope, accountable, efficient, and equitable. The block grant system violates every one of those criteria.

Maxine Watson Reinstated In Housing Job

Following a three year legal battle with the city, Maxine Watson has been reinstated as a tenant relations officer for the North Las Vegas Housing Authority. Her reinstatement comes as a result of a Nevada State Supreme Court Decision.

"I think it's a landmark decision," City Attorney George Franklin said. "You must now give them a notice of intent to fire and then you can't fire them without a pre-termination hearing."

Watson, who had been with the Housing Authority 11 years at the time she was fired, now looks forward to returning to work there. She appealed her dismissal, when, on Sept. 1, 1978, she was fired by then Housing Authority Directory Joe Hansen, who gave poor relationships with tenants,

causing dissention within the ranks of the housing authority, inability to be trusted with assignments, and inability to communicate sufficiently as a tenant relations officer, as the four reasons for her dismissal.

Watson's attorney, Marilyn Romanelli, is now in the process of negotiating the amount of money Watson is to receive — possibly from \$35,000 to \$50,000. It would make about as much sense to turn national defense into a block grant program and rely on state National Guards for our security. Absurb, isn't it? Yet that is what we propose to do with programs essential for our domestic national security and

Murder Trial Ordered

Last Tuesday, Catherine Smith, 34, of 911 North "E" Street, was ordered to trial on the charge of murder, by Justic e of the Peace Earle White, Jr. following a preliminary hearing. Smith is accused of shooting John Baxter at her home on June 27.

Deputy District Attorney David P. Schwartz called witnesses who testified that the shooting climaxed an argument over whether or not Baxter was going to leave.

Smith, who is being held in Clark County Jail in lieu of bail, is scheduled to be arraigned on July 22 before District Judge Howard Babcock.

regulation and taxation which is responsible for the slowdown in productivity increases. They seek to gut many regulations which protect workers health and safety and to provide huge tax breaks for corporations and the wealthy as a way of increasing productiv ity. Yet if one looks to other

advanced industrial democracies which are outpacing us in productivity increases, we see that these countries have even greater government intervention in the economy and very often have higher rates of taxation. In addition, these countries have well-develo ped programs of worker participation in workplace decision-making and codetermination...
