substitute their will to that of their constituents. It is far more rational to suppose that the courts were designed to be an intermediate body between the people and the legislature, in order, among other things, to keep the latter within the limits assigned to their authority. The interpretation of the laws is the proper and peculiar province of the courts. A Constitution is, in fact, and must be regarded by the Judges as fundamental law." You might say Hamilton saw the likes of Senators John East, Orin Hatch and Jesse Helm back in 1778.

Let us hope that there is a Hamilton in the Congress today to reinterpret what the founders meant when they: penned that document called the Constitution.

****** WAITING CHILDREN*****

At the time of her birth, Roxanne was a normal, healthy black baby girl. At a very young age she sustained massive trauma as the helpless victim of severe abuse. She suffered a skull fracture and multiple subdural hematomas. As Roxanne turns four years old this July, she has profound special needs as a result of these injuries. Her current diagnosis includes spastic quadraplegia, blindness in her right eye, severe psychomotor retardation and a seizure disorder which is controlled with medication. Her present development is at a three to four month old level.

It is unlikely that Roxanne will ever walk or talk. She spends her waking hours in a wheel chair and she can only make sounds. However, she has made improvements. She now can sit up alone and crawl across the floor. She is making inconsistent progress in turning over and she is gaining control of her head. She feeds well and has learned to drink quite well from a cup.

Yet, her prognosis is not encouraging.

Even with all her Roxanne problems responds to attention. She likes to be hugged



and cuddled. She enjoys being taken for walks and also listening to music. Roxanne needs the love and security of a permanent home as well as physical and occupational therapy. She also needs routine care by a physician and follow-up by neurologist who could monitor the control of her seizures.

But Roxanne doesn't have that permanent home. Instead she waits in a foster home for someone to adopt her. Only a very special family could meet her profound needs and rejoice in her small accomplishments. If you are interested in parenting a child with profound special needs like Roxanne, contact Aid To Adoption Of Special Kids. Roxanne is just one of many such children who need parents and wait with little hope unless you respond.
