WAITING CHILDREN

James is an active and curious black boy with a big smile for everyone. He is an attractive twelve-year-old who is somewhat small in stature. Like most boys his age, James spends every minute possible playing with his neighborhood friends. He also enjoys television and summer camp.

James attends special education classes and tests near borderline in intelligence. However, his low scores are believed to be from environmental causes. In an adoptive home that could provide both stimulation and encouragement, James's potential should increase markedly. A permanent family could also provide the emotional security James needs.

Currently James does best in a well-structured atmosphere where rules and limits are clearly established. He is hyperactive, but this is controlled by the drug Ritalin. Generally he is a happy, outgoing youngster who is eager to please and responds to love and attention.

James is waiting in a foster home for a family willing to adopt him. He has a thirteen year old sister named Gina who has already been adopted. He would like to keep in touch with her if possible.

James's sunnv disposition would bring endless joy to any family that could find a place for him. Adoptive parents could experience much satisfaction watching James blossom to his fullest potential. James is waiting. Is a family too much for him to hope for?



HOW CAN YOU ADOPT

The child described in this column is waiting for adoption. Nationwide, there are over 300,000 children who, for various reasons, have not found permanent parents, some have physical, mental or emotional handicaps; some are of mixed racial background; some are older. Others are siblings.

The Las Vegas SEN-TINEL, working with AASK (Aid To Adoption Of Special Kids) hopes to find homes for these children.

Subsidies (payment to the adopting family each month medical expenses) are available for many of the children.


