COUPLE CHARGED WITH MURDER

Tony Ray Hines, 22, of 209 W. Monroe Ave. and Amanda Faye Conway, 22, of 1928 W. Lake Mead Blvd., the Las Vegas couple charged with the murder of a Strip hotel guest, were ordered to trial Wednesday by Justice of the Peace John McGroarty in District Court, following a preliminary hearing.

Evidence against the pair was presented by Deputy District Attorney

Mel Harmon. They are accused of shooting Grace M. Quinn on the afternoon of July 5 in her room at the Frontier Hotel.

Harmon's key witness was James Quinn, husband of the victim, who identified Hines and Conway as the killers, whom he saw fleeing the scene as he was approaching the room. He said Hines pointed a gun at him as he fled.
