NEW TOWN TAVERN TO OPEN WITH NEW "LOOK" AND FEATURES



On May 23 a blaze of suspicious origin destroyed the Landmark New Town Tavern, 600 Jackson Ave. causing an estimated \$200,000 damages. Starting in the rear of the building, the fire soon spread through the attic and roof and finally involved the entire large one-story building. The well-known West Las Vegas cocktail lounge and casino had attracted a heavy patronage for more than two decades. Construction is now underway and the plan is for the New Town Tavern to formally reopened around September 1. It will include a Sportsbook — a first in the black community, a new casino with a poker room, slots and other gaming activities plus a fashionable bar., A couple months later a new showroom will be constructed on the property located on the westside and adjacent to the building. Next week, the SENTINEL will feature an architectural rendering of the newly remodeled structure.
