#### Rent Rebates Now Discussed

The last session of the Nevada legislature provided in its tax package for decreased property taxes. This law stipulated that 90 percent of the realized savings experienced by landlords should be passed back to their tenants.

The law became effective July 1.

Therefore, Nevadans who rent homes, apartments or businesses should soon be receiving a rebate from their landlords.

Property owners are now receiving a notice about their taxes which tells them what their tax would have been prior to the legislature's new tax formula and what it is now with the formula in effect. The difference between the two is the sum of money the landlord must rebate back to his tenants.

The landlord must also figure the amount of rebate going to tenants on the basis of the number of rooms that a tenant rents. For example, more rebate must go to a tenant renting a two-bedroom apartment, than to one who rents ar

one-bedroom apartmen-

The rebates must be figured by the landlord as of July 1, even if the landlord is not able to do his computations until September and is not able to return the money until that time. The rebate will be in effect for one year.

The legislature also provided for the enforcement of the rebate plan to tenants. It funded two additional positions for the taxation department to help enforce the rebate formula. If a property owner fails to rebate any money to a tenant, the tenant may file a complaint with the taxation department.

The department may in turn take several actions including contacting the landlord and explaining the law to him. If the landlord still refuses to pay the rebate, the department can then subpoena his records, figure out what the landlord owes the tenant and then notify the tenant, who can then go to court and sue the landlord.

The rebate law also applies to stores which lease space from landlords.

#### Culinary Eagle Watch Paper To Be Printed

A group of members from Culinary Union No. 226 have organized a new 'watchdog' organization named Eagle Watch, whose purpose, according to pledges of its members, is to keep an eye out for abuses of rank and file members by both employers and the union itself.

The organization will publish a newspaper, which is scheduled to come out with its first edition this weekend. According to one of Eagle Watch's organizers, Dennis Mc-Carthy, 30,000 copies of paper will be distributed throughout the Las Vegas area in hotels and other locations convenient to union members.

Money for the paper, which is to be published monthly, comes from the members' pockets and donations from sympathizers.

This first edition will introduce the officers of Eagle Watch and will urge members to vote in Tuesday's election for the local three-member joint executive board, which is responsible for negotiating union contracts.



activity, a condition which could, as we are now learning, physically damage an individual immensely. Many of these people have to give up their jobs without knowing whether or not they are going to get another one.

It was these conditions which led PATCO to endorse Ronald Reagan for President in 1980. Mr. Reagan had indicated in a letter to PATCO in October of 1980 that he understood their problems and that if he was elected President, a solution would be forth coming.

Mr. Reagan is now President and his solution to PATCO problems has been to fire them for striking and to have their leaders placed in leg irons and cuffs and hauled off to jail. Mr. Reagan takes the position that when the air traffic controllers were hired, they took an oath that they would not strike. He states further that the strike is illegal and against the law. The logic which Mr. Reagan seems to be employing is that as long as there is a law, irrespective of the working conditions, the controllers should not strike. This logic would have made Adolph Eichmann an innocent man. Eichmann killed six million Jews following the law.

Thoreau, Gandhi, King — all of these gentlemen have taught us something about civil disobedience to an unjust law. The PATCO strike is not illegal in the true sense of the word, but an act of civil disobedience toward recalcitrant men who would use the law to hide their failure to correct an unjust condition. If anyone sees that an injury could come to himself or others, he has a duty to act in a fashion which would heighten the conscientiousness of others toward redressing the problem.

This is what PATCO is doing.
