





some degree, an atmosphere where the school board and the superintendent can carry out their proper functions.

Since there appear to be diverse opinions and different agendas held by different Board members regarding the goals of the Clark County School District, notwithstanding the "statement of educational principal" as reflected in policy, the following concepts are offered for consideration, keeping in mind that the only official acts of the Board must be accomplished at posted meetings and not by individual Board members:

1. Official determination must be made as to the development of the search for the superintendent of schools. Questions should be answered as to:

a) will the Board develop the procedure for the search?

b) will the procedure allow for expenditure allocations to conduct the search?

c) will the Board set the criteria for the application process?

d) will the Board develop the announcements for distribution?

e) will the Board develop the screening forms for initial screening?

f) will the Board allow for broad based community input into the process?

g) will the Board retain an outside firm to conduct the process?

h) will the Board hire a consultant if it intends to handle the process?

i) will members of the Board visit the candidates' present communities?

Regardless of the answers to the nine questions posed above the following two actions must officially take place before the Board hires a new superintendent.

> 1. By official action the School Board must authorize the development of a procedure to recruit a superintendent. Either the Board will authorize itself, someone, or some agency to developed the procedure.

> 2. The Board must then authorize the implementation of the procedure that was developed by official action of the Board.

The two steps outlined above seem simple, however, these requirements and commitments are critical. Since I am the only Board member with experience in this area, and knowing how end-runs and individual idiosyncracies invade the process as it proceeds, it is of utmost importance that the two steps above be clearly and succinctly developed. 'Personal preference, manipulation and self-interest must be avoided at all cost for the sake of the children in the Clark County School District.

It is felt that the final decision should be broad based. There should be wide community input before any selection is made by the Board.

The Board meets on the second and fourth Thursdays of each month at 7 p.m. at the School District on Flamingo Road.

We urged that everyone get involved, for the community at large will better be served for the benefit of the many children who are served in the local school system.
