

and which so adequately rises to the task of musically supporting the great voice of Marlena.

LVJS president Monk Montgomery announced that in the following months, the Las Vegas Jazz Society will be presenting Maynard Ferguson in December; Carmen McRae in January.

own standard of living it is often difficult for many Americans and their West European counterparts to understand why massive aid to refugees is of vital importance. Black Americans disproportionately suffer from unemployment and poverty. And some blacks have argued that we should take care of our own problems first and not worry about those of the rest of the world. Yet this, in my judgment, is a remarkably shortsighted and narrow point-of-view. For if America is not willing to help in relieving the plight of those refugees who are starving and near death how can we be sure it will be compassionate enough to solve the problems which afflict our own nation's poor and working poor? It is important for blacks and all Americans to realize that suffering knows no boundaries.

Our country has historically provided a haven for the world's refugees. In part, it is their contribution which has helped to make our country great. American policy must continue to reflect this tradition. This policy must reflect the spirit of the Nobel Committee's award statement.

"Refugees who dare not return to their native land must be given an opportunity to start a fresh life in their host country. Still more important in the long run is the work of insuring that people are not compelled to save their lives by escaping from their native land with no prospect of ever returning."

America can continue to help alleviate the plight of the world's most unfortunate. Yet America will only do so if its leaders recognize that compassion knows no boundaries and that government must play a vital role in alleviating suffering both at home and abroad.

low profile in the state.

Klan demonstrations. marches and rallies sometimes leading to violence - are occurring more frequently in other parts of the country, however, and "Klanwatch" is attempting to document those actions, Dees said. The group, comprised largely of Southern Poverty Law Center staff, also is compiling dossiers on Klan leaders and members from around the country.

Dees estimated that "Klanwatch" has identified nearly 500 Klanmembers in 16 Southern states, as well as California, Pennsylvania, Ohio, Indiana and some in Canada. He said his group attempts to establish the rank Klanmembers hold and track their movements.

The Southern Poverty Law Center is a legal organization which has filed numerous class action civil rights lawsuits on behalf of minorities and the poor.

Dees said his staff utilizes a variety of methods in its "Klanwatch" efforts, including the use of a service which clips Klanrelated stories from 13,000 publications. The collection of Klanmaterial from daily and weekly newspapers and magazines is augmented by photographs and video tapes of Klan activities.

The Klan information will be available to journalists reporting on the Klan, Dees added, and a regular compilation of Klan actions throughout the nation will be included in a newsletter being sent to reporters.

A videotape of Klan members attacking a group of black marchers in Decatur, Ala., was made available recently to the "Phil Donahue Show," which featured Klan leader Bill Wilkinson and Georgia state Sen. Julian Bond. Wilkinson is the Imperial Wizard of the more militant faction of the
