## **Benitez Retains Super Welter Title**

"It turned out to be a sluggish fight. It wasn't his best performance, but he won the fight,' said Emile Griffith, trainer of World Boxing Council super welterweight champion Wilfred Benitez.

Griffith's comments summed u the feeling of a majority of the fans at the Showboat Hotel **Sports Pavilion Saturday** night where Benitez scored a unanimous 15round decision over previously-undefeated Carlos Santos.

'It was good to have a bad night once in a while and still win," added Griffith, a former world welterweight and middleweight champion.

There was one "official" knockdown in the fight in the seventh round when Santos,

had slipped.


