That might be a justifibale defense of a program that put in real public service jobs, such as the CETA program slated for elimination, or in a real-world training program. But Workfare?

Poor people know the score. They can tell a real job from a fake one. And they can tell a real opportunity from a forced work situation whose true aim is to make taxpayers feel the poor aren't getting something for nothing.


By definition, AFDC families are made up of children and female family heads. The help those families need is not forced make-work programs or ruthless cuts in their food stamps, housing aid and welfare checks.

If the Administration was serious about changing the present unworkable system and providing incentives to work it would introduce true reforms.

Real jobs and skills training, day care centers, and a retention of benefits for the working poor would be part of such reforms.

A refundable income tax that eliminates the administrative and police work in welfare and provides each family with the minimum it needs for a decent standard of living should be the key to a new federal income maintenance program replacing welfare.
