battles. We got all those sage editorials about supply side economics and the Administration's theories. Now the media is left with mud on its face, for it took on face value what even the Administration's proponents never believed.

Even now the media h e a d l i n e s the President's "support" of extending the Voting Rights Act without adequately explaining that he backs changes in the Act that would reduce its effectiveness.

Again, the media reports the President's eloquent statements about civil rights, without informing people that its actual proposals would effectively gut civil rights enforcement.

It wasn't until the President's appointee to head the Equal Employment Opportunity Commission was on the eve of his confirmation hearings that the press finally got around to pointing up his obvious inadequacy to hold such an important post. One must wonder whether such a nominee was chosen to intentionally discredit the civil rights enforcement responsibilities of the federal government.

So the Washington revelations have opened up a credibility gap for this Administration. The skepticism minorities voiced about its policies and intentions have been confirmed.
