Blacks and whites do not mix. Integrated gatherings are made the subject of harassment. According to a report in the May issue of *Ebony Magazine*, in many instances, "blacks are subjected to arrest if they socialize with whites." And despite the fact that 42 percent of Pickens County is black, no black candidate has ever been elected for county-wide office.

It was in this context that Mrs. Maggie Bozeman, 51, and Mrs. Julia Wilder, 70, conducted their quiet work of registering minority voters. Mrs. Bozeman and Mrs. Wilder not only were active in efforts to in-

crease black voter participation, but through their work in the Pickens County Voters League and the NAACP, they had earned the reputation of being the county's top civil rights

activists.

Their careers, although worthy of praise, would not have earned them much public attention if not for the fact that they were charged with voter fraud by the Pickens County authorities. It turns out that in 1978, Mrs. Bozeman and Mrs. Wilder were active in helping illiterate and elderly black voters cast absentee ballots during a Democratic Party primary. Each of these absentee ballots was duly notarized and properly handled. Yet one 79-year-old woman, who had signed an absentee ballot, turned up at the polls and insisted that she had not signed any such document. When 12 other black voters testified that they had consented to use such ballots, the elderly woman merely asserted that she couldn't remember signing.
