CHANEY BLAMED IN \$15,000 LOSS

Assemblyman Lonie Chaney denied last Saturday that he is responsible for the disappearance of \$15,000, that he blocked a person's chance to buy a motel and jeopardized her ownership in several other properties.

He has been accused of these allegations by Charlene Perkins, who along with her husband, Arnett, was appointed as manager of the Warehouse Motor Inn, by

Bankruptcy Court in late 1980.

The Inn, located at 950 W. Bonanza Rd., is still going through bank-ruptcy.

According to Perkins, she and her husband had desired to purchase the inn. They were going to buy it from Charles Grangaard, debtor-inpossession, who wanted \$425,000 for it.

They had initially made a \$15,000 down payment (they had with-

drawn their life savings from the bank to do this) to Tony McCormick, who was acting as their financial advisor, and was to have placed the money in escrow. The

Perkins' found out later that the money had never been placed in escrow and McCormick has disappeared. The loss of the money has
