

WAITING CHILDREN

Thirteen-year-old Lori is a friendly and outgoing black teenage girl. She enjoys vigorous physical exercise such as running, jumping and playing ball. She also enjoys dancing. While Lori will work happily at tasks which she enjoys, she becomes easily frustrated when trying to complete difficult tasks. She is usually enthusiastic in her play and is sometimes perceived as being too rough.

Lori is considered to be severely mentally retarded, therefore she

has to work very hard to make progress. Through hard work and consistent, patient guidance



Lori has acquired a number of social and self-help skills. Lori enjoys interaction with

adults and with her peers and she is both a friendly and affectionate child.

What Lori needs most is a warm, loving family who can accept her as she is and work with her to achieve her full potential. But Lori doesn't have a family, at least not a family of her own. She waits in foster care system for someone to care enough to adopt her. Lori needs a black family to open their hearts and their home to her — to become a "forever" family for Lori and put an end to her years of waiting.


Each bidder must deposit with his bid, security in the amount, form, and subject to the conditions stipulated by the Owner.


No bidder may withdraw his bid within forty-five (45) calendar days after the actual date of the opening thereof.

CONSUMER AFFAIRS PROBLEMS AND ANSWERS

QUESTION: I have lived in my apartment for about 2 years. During this time I have never been able to get the names of the owners of this building. It's a strange operation so I want to know who is behind all of this. Am I entitled to obtain the names of the owners.

ANSWER: You certainly are entitled to this information. The Nevada Statutes specifically states that the tenants are entitled to this disclosure. It states that the landlord, or any person authorized to enter into a rental agreement on his behalf, shall disclose to the tenant in writing at or before the commencement of the tenancy: (a) The name and address of the persons authorized to manage the premises; (b) the name of the owner or the person authorized to act for and on behalf of the landlord for the purpose of service of process and receiving notices and demands; and (c) the principal or corporate owner. After a demand by the tenant, if the landlord fails to disclose the above information, the tenant may recover actual damages or \$25, whichever is greater.

The Nevada Consumer Affairs Division is mandated to enforce statewide the laws covered under the Deceptive Trade Practices Act, the Automotive Repair Act and the Door To Door Sales Act. The agency is designed to protect and serve the needs of consumers and business persons alike through its offices in Las Vegas and Carson City.

YOUTH WOUNDED IN GANG CLASH

A youth was shot in the ankle Thursday night when gang violence in a West Las Vegas low-rental housing complex erupted into gunfire. Police reported Henry Flowers, 17, of 2058 Cindysue Street as the wounded youth.

According to police, the violence began with a rash of bottle throwing between a gang of white

motorcyclists and a gang of young blacks in the large housing project, where members of both gangs live. Although some of the bottles were firebombs made with gasoline and lighted rags for fuses, there were no fires and no other damage occurred, police said.

Three potential suspects were taken into custody for questioning.
