

The 28-year-old Limon, from Mexico City, has a 45-11-2 record with 33 knockouts and is a former WBC 130-pound champion. He won the vacant junior lightweight title on Dec. 11, 1980, in Los Angeles by stopping Ildefonso Bethelmy in the 15th round. His next time out, on March 8 in Stockton, he was decisioned and dethroned Boza-Edwards. Limon's last outing was on Dec. 10 in Los Angeles when he halted journeyman Darrell Stoval in the fifth.

Navarrete turned pro in 1973, three days after his 16th birthday, and Limon in 1972 at the age of 18. Both men have learned their trade well over the years. So well, in fact, that both have been accused on more than a couple of occasions of using questionable tactics.

Limon doesn't duck the subject, and has been quoted as saying, "I'll do anything I have to to win the title back. If I have to I'll spit out my mouthpiece and bite him. I'll even kick him." But what he says and what he actually does in the ring remains to be seen.

Navarrete has not come forth with similar statements, but if actions speak louder than words he proved himself to be one tough customer outside of the ring as well as in it two months ago. That was when he totaled the car he was driving and had to be cut out of the wreckage by a tool known as the "jaws of life." He emerged from the pile of metal with only bruises.

Both men made unsuccessful bids for the WBC junior lightweight title against thenchamp Alexis Arguello prior to eventually winning the crown. Navarrete was stopped in the fifth round on April 27, 1980, in San Juan while Limon was halted in the 11th on July 8, 1979, in New York.
