people and the general population and 83 percent of the Hispanics affirmed this belief.

Overwhelming percentages of blacks also expressed belief that each of the 10 commandments "applied fully." Even though there were significant drops in numbers in agreeing to the second and third commandments, which prohibit the taking of the Lord's name in vain and the keeping of the Sabbath holy, blacks still scored significantly higher. 84 percent of blacks believed that the Lord's name should not be taken in vain, compared to only 57 percent of the young people, 68 percent of the general pop-ulation and 76 percent of the Hispanics. Only 45 percent of the young people agreed that the Sabbath day should be kept holy, compared to 57 percent for the general population and 61 percent for the Hispanics. Again, blacks scored highest, with 75 percent agreeing that the commandment to keep the Sabbath holy "fully applies."

WILSON DENIES UNION TROUBLE

"There is nothing wrong with this credit union. It is stronger than it has ever been. We're a \$1 million operation now. We have over \$800,000 out in loans to our members."

This statement was made by Clark County Commissioner Woodrow Wilson in denial of allegations that the Westside Federal Credit Union, of which he is treasurer/manager, is in financial trouble.

The Westside Federal Credit Union, founded in 1951, was organized to service Las Vegas' black community during an era when commercial bank loans were unavailable to blacks.

The WFCU was audited by Stan Shakespeare, an examiner for the National Credit Union Administration, on Feb. 28. His report cited no major problems or discrepancies, but it did pinpoint several areas of operation that need improvement. He recommended that the credit union try to reduce its ratio of delinquent loans to total loans and also cited that the individual share and loan ledgers were

out of balance with the control accounts.

The federal audits are conducted on an annual basis and the credit unions are given no advance warning as to when the examinations will be coming.

Wilson said, regarding the discrepancies, "Our loan delinquency is a bit higher than it has been in the past due to the economy.

"We have no missing checks," he said. "If that had been the case, the federal examiner would have picked it up. We have never been short of money."

He also vehemently denied that the credit union officials had moved money from the credit union's operating expenses to its general fund account to balance the books.

"That wasn't done because I'm the only one who can do that and I'll stand on a stack of Bibles and say I didn't do it," he said. "I have no idea who is behind this, but it's not fair to hurt innocent people just to get at me. I don't care if they're after me, but they shouldn't try to destroy something that has been of value to our community since 1951."
