Gov. List **Establishes Guard Reserve** 

**Governor Robert List** today announced the establishment of the Nevada National guard Reserve as a division within the State Military Department.

Colonel Barney Rawlings of Las Vegas has appointed been Brigadier General to head the new program which will operate under the direction of the State Adjutant General, the Governor said.

The all-volunteer Guard Reserve is designed to augment existing state and local forces during emergencies and to replace those active National Guard units called to Federal duty. When the Guard vacates its armories enroute to mobilization stations, the **Guard Reserve would** assume responsibility for protection of buildings and other state property left behind.

"This new organization should greatly improve the State's emergency response capability," List noted. "Dedicated and capable volunteers have long been our strength here in Nevada," the Gover-nor said. "Now for the first time, we will be able to use this resource in support of the National Guard and its State missions."

# **CONSUMER AFFAIRS PROBLEMS**

AND ANSWERS

QUESTION: I have lived in my apartment for about 2 years. During this time I have never been able to get the names of the owners of this building. It's a strange operation so I want to know who is behind all of this. Am I entitled to obtain the names of the owners.

ANSWER: You certainly are entitled to this information. The Nevada Statutes specifically states that the tenants are entitled to this disclosure. It states that the landlord, or any person authorized to enter into a rental agreement on his behalf, shall disclose to the tenant in writing at or before the commencement of the tenancy: (a) The name and address of the persons auhorized to manage the premises; (b) the name of the owner or the person authorized to act for and on behalf of the landlord for the purpose of service of process and receiving notices and demands; and (c) the principal or corporate owner. After a demand by the tenant, if the landlord falls to disclose the above information, the tenant may recover actual damages or \$25, whichever is

LIBRARY CARDS

A library card is issued free of charge to any person who can verify his or her current address. Cards may be obtained and used at any of the participating libraries listed. The card must be presented whenever materials are checked out. There is a \$1 charge to replace lost or stolen cards. Cardholders must notify the library immediately when the card is lost or stolen.

### LOAN PERIODS

Books	 	 3 weeks
<b>Reserved Books</b>	 	 2 weeks
Art Prints	 	 6 weeks
16mm Films	 	 24 hours

Books may be renewed once at the library, provided there are no reserve orders waiting.

### **OVERDUE CHARGES**

There are NO OVERDUE CHARGES for children's books, or for paperbacks or magazines.

Overdue charges of 10 cents per day, up to a maximum of \$1 per item, are assessed for other materials.

### **DELINQUENCY POLICY**

An account is considered delinquent, and no further materials may be borrowed, in any of the following cases:

- 1. There are five books overdue.
- 2. There is \$2.50 in overdue charges accrued.
- 3. There are unpaid bills of \$2.50 or more.
