PEOPLE, PLACES and POLITICS

This past week I had an opportunity to appear on "Public Report," hosted by Lee Winston on Channel 10 TV, with Joseph Yobionski, the number one "YOBO" of the Nevada Scam. You are probably aware that Yobionski is the Special Agent in charge of the local FBI office.

As a legislator, my appearance on "Public Report" was the first public comment I have made on the YOBO operation in Nevada, which apparently has entangled many of our politicians in a web of political corruption. My position on this issue is and has been that if one is not predisposed to engaging in political corruption, one does not have anything to worry about. The legislator takes an oath of office to uphold the Constitution and laws of the state. The laws may be flaky at times, but the Constitution remains the primary source by which good and bad

laws can be judged.

The Constitution is the main marble in the legislative game. It is the one thing the legislator can always go back to for direction. The national Constitution as well as the state Constitution embodies the primary concept of democracy. They speak to the importance of each individual and each has a dignity which must be upheld. To operate for one individual or just for your group in the legislative process is to do damage to the concept of democracy by limiting the access of others to you.

Admittedly, there are pressures which are placed upon the public official to engage in illegal activity. But in order to continue to be embraced by the public trust and assure that democracy works, the public official must be able to discard the illegitimate for the legitimate. In other words, he must be able to say "no" to political corruptive activity and report same to the proper authorities.

All public officials who do not subscribe to the above concept need to be investigated. I do not think it is wrong to employ the method of a "YOBO" operation to do this. While the action of the "YOBO" operation is pretending, the public official usually means business if he is accepting cash to do things which he is obligated to do by law. When this does occur, it is not a question of entrapment as some would have us believe. It can best be described as greed if you seek to enrich yourself by taking money "under the table" for engaging in an illegal purpose.

HELP WANTED: SUMMER JOBS FOR YOUTH

With unemployment climbing well past the ten million mark, there is a danger that the urgent problem of finding summer jobs for disadvantaged young people will go by the boards.

With companies laying off long-time workers, little thought is being given to creating the temporary jobs that young people can fill until school starts again in the fall.

And the problem is compounded by deep cuts in federal summer youth job programs. Not only will there be far fewer subsidized summer jobs available this year, but the entire program is slated to be ended in the future, folded into block grants to the states where summer job programs will have to compete with other needs for scarce resources.

In city after city, mayors are worried about their ability to mobilize voluntery action by business to plug the gap, and about the results of the fallure to do so

That has led to dire warnings about the possibilities of increased youth crime and even "long, hot summers." I don't think that kind of speculation serves any useful purpose, for there are strong positive reasons to create work opportunities for young people; reasons that transcend the more sensational aspects of the problem.

Work experience and work habits are essential if young people are to take their place in the economic mainstream.

Study after study shows that young people who work while in school or during their summer vacations go on to better jobs and higher pay as adults.

Short changing those kids now means they'll need to succeed. And the lack of jobs also endangers their chances of staying in school, for too many wonder why they should continue their education when there is so little chance for a decent job at the end of the line.

Long-term, this has deep implications for the economy. As it shifts to producing services and high technology products, it needs a work force that is more highly skilled and better educated than in the past.

If our government doesn't seem to understand this, I am hopeful the private sector will. In some cities business groups have come together to pledge

Every since the evening of the "This Is Your Life" Tribute to Bob Balley on June 5, Dr. McMillan has been offering unsolicited explanations for his squiring the Congressman around that evening, introducing him to those who didn't have a chance to duck.
