


## **Veterans News**

SAN FRANCISCO — Legislation signed by the President last month includes a provision which allows the Veterans Administration to reimburse Vietnam-era veterans and eligible dependents for correspondence training begun after Sept. 30, 1981.

The law ends a moratorium on payments for new enrollments in such training which had been imposed for fiscal year

Reagan Administration places it in a predicament whereby a "yes" or "no" answer could cause problems either in the Armed Services or with Germany and the other NATO Allies. The Reagan Administration, I'm told, rejected this request and proclaimed the readiness of the United States forces in Europe.

There are those who would argue that the reason for the Reagan Administration's rejecting the NATO Alliance request to reduce the number of Black troops in Europe was because it did not want to attract attention to the fact that so many blacks were now in uniform.

The Administration needed a better way of approaching this issue than just handing out reassignment orders to a lot of black servicemen. With pressure already on Reagan in this country for his seemingly racist policies, any acquiescence to the Germany request would have been a racial coup de grace for the Administration among blacks of this country and indeed, of the world.

The Administration's approach to this issue of reducing black troops in Europe was to employ the services of the Brookings Institute to do a study of blacks in the military. The conclusions at which this study arrived, were that if this country engaged in a war, blacks would have a disproportionate number of casualties. It was further stated in the Brookings study that there may be difficulty with blacks being assigned to domestic tasks.

We believe that this Administration will attempt to find a way out of the black troop issue by the use of the Brookings Study. If it can be satisfactorily shown that it is discriminatory to have so many black troops on the front line, then the Administration would be able to heed the Europeans' request.

We would be opposed to any acquiescence to the European request, which is underlined with a racist base for the reduction of black troops, because anything which is black is presumed to be of low-quality and not capable of discipline or dependability. This is a racist concept and, as such, should not be utilized against our black troops, because the color of their skin is something over which they have no control.
