## **MINISTERS' ALLIANCE CALLS FOR** UNITY TO HELP DEFENDANTS IN UNDERCOVER OPERATION

More than 200 area residents attended the rally last Thursday night at the True Love Missionary Baptist Church, 1940 N. "H" St. where the Black Ministers' Alliance urged support for the score of defendants arraigned on charges of food stamp trafficking.

Rev. Albert Dunn spoke before the group and called for the ouster of Sheriff John McCarthy. "We've got to put McCarthy out of office. I saw him smiling in a picture when a 68-year-old woman and

her 72-year-old husband were arrested for selling a precious radio for foodstamps to buy something to eat."

Rev. C. Lee Murray, arrested along with his wife for allegedly selling two tanks of gas for tood stamps, said he thought it was funny that the undercover officer would entrap him.

"If he had asked me, I would have given him the gas," Murray said. "I had not done one thing that I feel guilty about."

Among those speaking at the rally were Rev. Willie Davis, Elder Jim Cox, Rev. I.W. Wilson, Rev. Ted Cuveston, Rev. S.P. Parks, Rev. Roy Wilson, Rev. James E. Allen, Raymond Blankes, School **Trustee Virginia Brooks** Brewster, Assemblyman Lonie Chaney, State Senator Joe Neal and others.

Scores of members of the black community formed a sea of support last Friday in U.S. District Court for 43 persons arraigned on food stamp "trafficking" charges.

More than 200 spec-

tators overflowed Courtroom 1 at the Federal Building while U.S. Magistrate Philip M. Pro ordered the charges read to the defendants and asked them for their pleas. All defendants who appeared in court pled innocent or had innocent pleas entered for them. Trial dates for those cases assigned to U.S. District Judge Harry E. Claiborne were set for Aug. 24. All cases given to U.S. District Judge Roger D. Foley were set for Sept.
