15-YEAR-OLD BOY NABBED FOR WEEKEND NAACP OFFICE BREAK-IN

Metropolitan Police reported Tuesday that a 15-year-old boy has been arrested in connection with a break-in at the Las Vegas NAACP office and an adjacent beauty supply store.

The NAACP office was reportedly ransacked during the weekend and approximately 25 complaints alleging discrimination against black employees had been

"For all we know, the NAACP office was entered for the purpose of going into the beauty supply area," said De-

tective Dale Horton. This was also the feeling of some members of Olga's Beauty and Supply office. The store was broken into from the NAACP office.

Six or seven juveniles were seen by witnesses knocking a two-foot hole in a concrete wall to enter the NAACP office, according to Metro police.

NAACP officials have theorized that the files of chapter President Lovell Gaines had been ransacked, probably for political reasons. Gaines is up for re-election to that post

Gaines said his files were searched and some financial records stolen. About \$20 in membership fees were untouched in Gaines desk, it was reported.

The NAACP office and Olga's Beauty and Barber Supply are located in the Nucleus Plaza, 932 W. Owens
