

It is the philosophy of the Conservatives to speak ill of those who seek aid and refuge from the political system. People who seek this aid and refuge are castigated and identified as "those on the public dole."

The Conservative philosophy does not engender a commonality of purpose in the operation of the governmental structure. The Conservatives are more attune to selective private interest. This interest is usually not operated for the public good. This is evident when the public is shafted by some builder, or a utility company receives an unjustified rate increase. The public complains but usually to the deaf Conservative ear.

Given my thoughts regarding the philosphy of the Conservatives, I was somewhat surprised when this local judge called me up to see if I would support Leavitt over Bryan for Governor and Santini over Cannon for the U.S. Senate. My answer is not only "No" but "Hell No!"

It is not that Bryan and Cannon share my views. They don't. They are conservative in many areas. But somehow, in the midst of their conservatism, there is compassion for people which has surfaced time and time again during their political careers. It is this substance that black people can call upon in time of need.

So, if the Conservatives want Bryan and Cannon out of political office, they should not get any help from the black community.


The decision on which the Democrats running for the U.S. Senate will deliver the first opening statement on Saturday will depend on the call on the coin toss, campaign officials said.


