

have continued in my former position and have been able only to vote for Senator Cannon, had not Santini opposed the Senator for his seat in the Senate.

My position was with a funded agency and I was "hatched" so I offered my services to the Senator's campaign at less remuneration than my former job. I don't idealize or idolize Senator Cannon or any candidate for public office. But I know Senator Cannon's concern for Nevada and all Nevadans. I know him to be a Senator of accomplishment, integrity and with a voting record he can run on with pride.

I know Santini cannot fill the Senator's shoes. I can imagine how he must panic about his future when he views the piethora of young Democrat talent we have in Nevada. I can understand why he would think he had to make his move now or be forever submerged by the likes of Harry Reid, Dick Bryan, Brent Adams, and — ad infinitum.

As for the Ministerial Alliance, I hope I am not alone in feeling sick at the continued "selling out" that goes on in the Black Community.
