



also the poorest, the most subject to unemployment, and the most vulnerable to dislocation in a changing economy.

When minorities made up a small fraction of Americans, their conditions were prone to be ignored. As their numbers grew and they became concentrated In urban centers, it became harder to ignore them, although the nation certainly did - and does.

But can America hope to survive as an economic and world power without finally meeting the needs and aspirations of onefourth of its population? Can such a huge minority continue to be

excluded from the mainstream without enormous negative results for the shrinking majority?

Obviously not. Nor will tokenism take care of the problem. Even if white Hispanics, the most assimilated Aslans, and the best educated blacks are grudgingly admitted to full opportunities, the numbers of those left behind will overwhelm the system.

But more positively, the growth of America's non-white population offers our nation a marvelous opportunity. By concentrating on job creation, skills training, and quality education, and by finally ending racism and discrimination, America can tap enormous new human resources.
