SANTINI IS THE CHOICE

Earlier in the week several of the local newspapers blazened headlines indicating that the Cannon, Santini contest was a toss-up. The reports showed a neck-and-neck political race and that possibly the Democratic primary would be decided by the undecided vote.

Independent polls are showing a winner in each camp but the bottom line will show Rep. Jim Santini the victor. Here's why.

A Nevada Poll commissioned by a couple of the state's leading dailles showed that Santini has raced to a 4 percent (45 percent to 41 percent) lead over Cannon. It also indicated 63 percent of the seniors had a "favorable" impression of Santini compared with a 47 percent rating for Cannon.

Among all the voters, Santini drew a 66 percent "favorable," 23 percent "unfavorable" rating. Half of the respondents were women, half men.

Santini is direct and positive. He has the uncanny ability to project the needs of his constituency. He is a hard working representative of the people.

"Effective representation means staying in touch with the people you serve. You must listen and be responsive, always remembering you work for them," said Santini.

Considered one of the brightest and most effective young members of Congress, we envision that his energy, alertness and well-rounded involvement will make him an outstanding, forceful U.S. Senator.

Santini is well prepared and does his "homework."

CEVA points out that despite the fact Americans are entitled to do far more electing than the citizens of any other democracy in the world, the degree to which Americans exercise their right to vote is cause for our concern because the voting turnout rate in the United States is far below that of most other democracles.

Example: President Reagan was elected in 1980 by the affirmative vote of less than 30% of the total voting age population because only 93,066,000 people (or 59.2% of the voting age population) actually voted. This means that 11,969,000 of all registered voters did not vote in that election and 64,020,000 of the total voting age population of America DID NOT VOTE!

Lay that figure on your non-voting friends when they start singing the blues and squawking about what's wrong with this country. If you don't vote, don't gripe is what we always admonish around the NAACP. And never, never forget that Black voters can make a difference. Elections have been won

Personally, I like the feeling I get when I walk out of the voting booth. I feel good because I asserted myself — asserted my opinions — asserted my right to vote. I know that every vote counts. There are too many recorded instances where an election was won or lost by one vote.

I couldn't wait to vote this election. More than a week ago, I waltzed down to the Clark County Election Department and asserted my right to vote by absentee ballot. I am not frivolous about my vote. It's not always easy to make a decision on which candidate to choose. It's easier here in Nevada because one has opportunity to meet elected officials and aspiring candidates more easily. I like to discuss candidates and issues with those whose judgement I respect and can trust.

There are times when one is less than enthusiastic about any of the candidates in a given political contest. Often, regrettably, one must simply settle for the lesser of the evils.

The ballot for Election '82 offers prize selections in the only federal race (the U.S. Senate contest) and in the statewide races.

They offered easy, actually mandatory selections to those seeking to elect leadership we can trust. I voted for Senator Howard Cannon's reelection (his record is overwhelmingly superior to his opponent). I voted for Harry Reid for Congress (isn't everyone?) Dick Bryan for Governor. (I have a longstanding commitment to Bryan) and Mahlon Brown for Attorney General (Brown's commitment to us and our community has been demonstrated over and over again).

Also important to me because I reside in Assembly District 6 is the re-election of Rev. Marion Bennett who has the experience, stature, dignity and know-how to enable him to give us better representation in the State Legislature. And, of

The problems we face will only be solved by good people, particularly those in public office who are willing to listen, fight and vote on our behalf. We believe Jim Santini is such a man. Unlike Cannon's workers who are paid, we have worked for him on a volunteer basis. The only reward we expct from him is fulfullment of his promises to the community. He offers a choice for our future and our children's.
