Fletcher was indicted on an open murder count. He is accused of taking part in the shooting of Russell Lemmon, 26, who was delivering milk Feb. 26 to CVT Gilbert Sixth Grade Center.

Fletcher was scheduled to be arraigned Friday before District Judge Jim Brennan.

Indicted last month on murder charges stemming from the Lemmon slaying were Ernest Oliver, 20, Michael Bass, 18 and Darrell Glover, 15. The trio is awaiting trial before District Judge John F. Mendoza.

All four defendants are being held in the Clark County Jall in Ileu of ball.
