

He became an active leader while serving as a teacher in the Dayton Public Schools. In 1967, he was named Educational Director for Dayton Opportunities Industrialization Center and in 1968, Project Director of the Model Cities Educational Program. In this post he developed a \$1.5 million program which received national recognition.

Dr. Thomas has served as Director of the Center for the Study of Student Citizenship. Director of the Bolinga Black Cultural Resources Center. A **Rockefeller Foundation** Human Resources Program Fellow, he was selected as Keynote Speaker for the National Education Association's Conference on Civil and Human Rights; speaker for the **National Black Caucus** Conference on Education for Blacks, and testified before former Senator Walter Mondale's Select Committee on Equal Educational Opportunity.

His publications have appeared in the Congressional Record, the Harvard Education Review. He is author of "Future Shock from a Black Perspective" and "Like it is," a compilation of interviews viewed on a nation-wide educational program of which Dr. Thomas is the host and which focuses on the concerns of the black populace. His guests have Included Rev. Jesse L. Jackson, Ossie Davis and Ruby Dee, Stokley Carmichael, Rosa Parks, Lerone Bennet, Maya Angelou, Dr. Lionel H. Newsom and Dr. Charles H. Wesley.

## EOB EXEC DIRECTOR ON INDEFINITE SICK LEAVE

It has been disclosed that David Hoggard, Executive Director of the Economic Opportunity Board of Clark County, plans to go on indefinite sick leave and probably will not re-

turn. Allegedly, the

last month that Hog-

gard had allowed

held the executive director post for over 15 years, is said to have amassed six months of sick leave, but it is not known if he will stay off work for that long.

The audit was called for by the state Office of Community Ser-

vices, which wanted an accounting of agency funds in 1981, the year that the office started allocating funds to the agency. \$200,000 In funds were cut off from the EOB shortly after the partial audit discovered the unauthorized loan and several other financial discrepancles. However, the funds were restored last week following an agreement reached by

the state and the EOB Directors.

According to Bob Rose, EOB attorney, part of the agreement involves personnel changes, but he declined to elaborate. However, it is felt that Hoggard will not return to his position.

In the interim, some of Hoggard's duties will be assumed by a recently appointed finance committee,

sources said. The committee is being headed by Ron Robison, a management analyst in the county manager's office.

In addition, the Economic Enterprise Corporation, a for-profit business set up by EOB, which the auditors found owed EOB \$55,000, has been disbanded and its holdings taken over by the non-profit agency.
