

Collins Upsets Bennett

In what was assumed to be a primary victory and a chance to return to the nevada State Legislature on Tuesday night, turned out not to be the case on Wednesday morning for incumbent Assemblyman Marion Bennett of District 6. Democratic challenger Gene Collins soundly defeated Bennett in what was to be considered by many indeed, one of the surprise upsets of election '82 in Southern Nevada.

Collins had received at last count, 1,275 votes (59.2%) as opposed to 878 (40.8%) for the incumbent five term assemblyman Bennett. In capturing the Democratic nomination, Collins will face 49-yearold Willie Neal, the Republican candidate in the general election in November. Neal defeated Albert Toomer, Jr.

Over in District 7, incumbent Democratic Assemblyman Lonie Chaney claimed victory over challenger Morse Arberry, Jr. thus enabling him to face the Republican nominee, Linda D. Brown in the general election in November. Brown defeated Levan McCurdy for that nomination. After the votes were cast, Chaney received 1,072 votes (49.6%) as opposed to 900 votes for Arberry (41.6%). On the Republican side, Brown received only 34 votes (60.7%) as opposed to 22 votes (39.3%) for Mc-Curdy.

In the hotly contested U.S. Senatorial race which fetured incumbent Senator Howard Cannon against his Democratic challenger, Congressman James Santini for the nomination Cannon surprised his opponent by a 5% margin. The final vote tally

was 34,393 (55.4%) for the incumbent Cannon, and 25,166 (40.6%) for the challenger Santini. Cannon seemed quite positive of a Democratic victory in November, hopefully with the help of his deposed challenger Santini, over the Republican nominee for the U.S. Senate, Chic Hecht. Santini assured Cannon of his support in the upcoming general election.

As stated, Hecht, the Republican nominee, sur-prised the "favorite" for the Republican senate nomination, Rick Fore. Also contending for that nomination were three more challengers. Hecht received 13,282 votes (44.9%) as opposed to

Fore's 5,981 votes. (20.2%)

Over in the Congressional race, on the Democratic side, Attorney Harry Reid proved to be the largest voter victor, percentage wise, with a 77.9% or 41,779 popular votes received for the newly created Southern Nevada Congressional seat. His Republican opponent in the race will be Peggy Cavnar, who surprised her challenger, James Lyman for that nomination. Cavnar received 14,474 votes (55.1%) as opposed to Lyman's 8,722 votes. (33.2%)

In the Governor's race, incumbent Governor Robert List easily defeated his main challenger for the nomination, Mike Moody. List received 15,349 votes (51.7%) as opposed to Moody's 7,049 votes. (23.8%) It was interesting to note in that Republican race that "none of these" received 6,469 votes or 21.8%. Add the "none of these" 21% with Moody's 23% received, Governor List might find a 44% number of disenchanted Republican voters, as was found on Tuesday when the general election arrived in another seven weeks.

Over on the Democratic side, Attorney General Richard Bryan had an easier time of defeating his nearest rival incumbent Lt. **Governor Myron Leavitt** for that party's nomination. Bryan received 33,008 votes (53.6%) as compared to Leavitt's 20,783. (33.8%) Stan Coltan was a distant third, receiving 4,700 votes, or a 7.6%

In the race for Lt. Governor, Bob Cashell was an easy victor, capturing 32,526 votes, (56.7%) on the Democratic side. Cashell will face Republican challenger Bill Boyd in



Marion Bennett, the general election in

November. In the Attorney General's race, B. Mahlon Brown will be pitted against Brian McKay. Democrat Brown defeated his nearest rival, George Franklin by 5,000 votes, andd McKay destroyed Marc Risman, his Republican challenger by 14,000 votes.

In the race for Clark County Sheriff, former police chief John Moran and incumbent Sheriff John McCarthy will "square off" in the general election in November. Moran overwhelmed his Democratic rival, Beecher Avants to capture the party's nomination by over 20,000 votes. Over on the **Republican side**, Sheriff McCarthy defeated his opponent, Dale Davis just as soundly by 13,000 votes.
