# **Editorial**

The Nevada tax shift has been ruled unconstitutional

by District Court Judge Howard Babcock.

Judge Babcock ruled that the entire tax package passed by the 1981 Nevada Legislature and signed by Governor Robert List violates the principles of the Nevada Constitution, thus setting aside, unless overruled by the Nevada Supreme Court, a law which shifted the burden of Nevada's taxes from the homeowner to the sales taxes.

Most of us are aware that the basic tax package proposed by Governor Robert List did not or has not accomplished what it was supposed to have accomplished. Instead of the sales taxes increasing with the visitors bearing a large share of the load, the reverse has been the case. The number of visitors to our state has decreased, therefore taxes have not come up to projections.

In his reluctance to call a special session of the Nevada Legislature and deal with the tax issue and the waning economy, Governor List has decided to cut all budgets that receive monies from the state to a "bare bones" budget. Possibly a noble idea, but in his desire to keep his promise to lower taxes, the good governor has forgotten. or shall we say overlooked, the fact that in order to accomplish his goal, working people have been released from their jobs. With no other jobs available the unemployment rate has risen to double-digit figures, thus reducing their ability to pay sales taxes, thus decreasing the amount of revenue going to the state, thus necessitating more lay-offs, more bankruptcies, more people losing their homes, etc.

The entire economic system in Nevada has been disastrously interrupted, with seemingly no one in power wanting to step forward to correct the problem during this voting year.

The tax shift may have been great politically, but in reality, it was unworkable from the start. Any clear thinking honest person could see an enormous amount of frustrating loopholes, probabilities, and devastating effects on the Nevada economy from the very beginning.

Let's be careful who we send to Carson City this time. and not let anyone tell us that the problems of Nevada are linked directly to the national economy and Reaganomics. Nevada has always stood on its own "two feet."



## VA NEWS

SAN FRANCISCO -"Am I eligible for a VAguaranteed home loan?" That's a question that Veterans Administration regional office employees are asked on a daily basis.

The GI home loan program was established in 1944 for veterans with other than dishonorable discharges. Active duty service people were added to the program in 1966. Eligibility requirements for veterans and service members is based on certain minimum periods of continuous active duty service.

eligible are Also spouses of service personnel who have been missing in action or listed as a prisoner of war for more than 90 days, and unmarried surviving spouses of veterans who died as a result of service or serviceconnected injuries.

The main purpose of the GI home loan program has been to help veterans finance the purchase of homes, at a favorable rate of interest, with little or no down payment. The guaranty, in effect, takes the place of cash down payments, encouraging private lending institutions to make loans they otherwise may not be willing to make.
