Organized in the dining hall of Zion Methodist Church, the first worship service was held in the Engineers' Union Building, then located on West Owens Avenue on the second Sunday in June 1960. Under a rental contract at that location, services continued for a year and a half. Victory was accepted in the

Manifestations of God's blessings were marked by the increasing ministries and membership of the church. There are the many faithful, yet among us, who labored in the service of the church in developing programs, committees and auxiliaries which became a part of Victory's order of worship.

By 1978 membership had grown to 500, about one-half of which received Baptism of the Holy Spirit. Viewed at one time by some as a "Mystery Church", Victory's integrated ministry had become a center of spirit-filled souls for Chirst, speaking in tongues, laying-onhands, casting out demons, teaching and evangelizing, among other signs of ministries as found in I Corinthians, Chapter 12. Pastor Thompson speaks of many miracles along the Victory journey. Paramount among the church's ministries is the teaching ministry, led by Pastor Thompson and assisted by other ministers of the church. Now, at a time of rejoicing for Victory, our teaching and growing ministry is witnessed in the recontruction and expansion of the Temple and the reestablishing of the Law of God, as found in Nehemiah, Chapters 4 and 8. This twentysecond year of rejoicing for Victory is another of the miracles in the life of our church, as we press toward the mark of the high calling of God in Jesus Christ -"Ye also, as lively stones, are built up a spiritual house, an holy priesthood, to offer up spiritual sacrifices acceptable to God by Jesus
