

In a recent study by U.S. News and World Report in its Crime In American special edition, crime in this country has increased tremendously in all catagories in just 12 short months. To make this true statement all the more distressing, our society, in trying to cope with fewer courts, jails, attorneys, and prisons are finding it a lot more conveniente to return the criminal element back to the street where a repetition of his crime could quite possibly, and has often reocurred.

Also, to add to those depressing and awesome realities, we seem to be witnessing daily the injustices of a society where those with the greatest financial resources, have the opportunity to buy the best that money has to offer in regards to courtroom defense attorneys, and they often walk away with verdict decisions in their favor.
