### **NAACP Prexy Seeks Atty. Archie Retrial** criminal involvement or

Las Vegas NAACP **President James Allen** said Monday attorney **Robert Archie deserves a** retrial on sex charges involving two teenage girls.

The Rev. Allen said the Saturday conviction of Archie, who is black, was the result of prejudice. Allen cited the all-white jury, the 19year-old key witness who admitted trying to extort money from the attorney as well as filing false rape reports against him, and his sources' reports that a prosecuting attorney had a personal vendetta against Archie.

He said it showed that it would be impossible for a black man to get a fair trial in Las Vegas "from an all-white jury

## **GOVERNOR PROCLAIMS** EOB DAY

Governor Richard Bryan has proclaimed June 29 as Economic Opportunity Board Day in Nevada in honor of the organization's 18 years of service.

The governor's proclamation reads:

WHEREAS, the Economic Opportunity Board (EOB) was founded in September, 1964 for the purpose of administering programs of the war on poverty; and

WHEREAS, the EOB has always been guided by the philosophy of President Lyndon B. Johnson that "the war on poverty is not a struggle to support people to make them dependent on the generosity of others...but a program to help men and women prepare long range goals for the attack on poverty in thier own local community;and

WHEREAS, THROUGH THE EIGHTEEN YEARS OF ITS EXISTENCE, EOB has served over 100,00 poor or low income persons; and

WHEREAS, THE EOB's governing board is comprised of representatives from all sectors including the public and private and poor; and

WHERAS the EOB provided the first senior citizens center in Clark County; and

WHEREAS, THE EOB has provided a number of other valuable services to senior citizens, youth and low income, which include health, education, transportation, employment and vocational training in both public broadcasting and gaming;

THEREFORE, I, RICHARD H BRYAN, NOW GOVERNOR OF THE STATE OF NEVADA, do hereby proclaim Wednesday, June 29, 1983, as ECONOMIC OPPORTUNITY BOARD DAY IN NEVADA and urge all Nevadans to honor this worthy association.

that he had been told by sources inside the courthouse that prosecutor Bill Koot had admitted privately to at least one person that he had a 'vendetta" against the handsome, 42-year-old Archie.

Allen refused to identify his sources.

It was Deputy District Attorney Koot who moved to disqualify the two blacks who had been called as prospective jurors in the case.

Koot explained that the disqualifications were not because they were black but because they either had previous had been associated with persons who had.

Allen said the trial is another example that racial prejudice exists in the system and the institutions of Las Vegas.

"There should have been some blacks some of Mr. Archie's peers - on that jury," Allen said. "The only two black jurors were kicked off the jury. I think the state wanted an all-white jury so they could convict him.

"There must be some blacks on the jury for the trial of any black man to be fair - at the very least. The jury totally overlooked what Archie's attorney's said and the information he had."

"This is not justice," he said. "They're (the girls) just as guilty. The D.A. should have been taken off the case for prejudice."

Allen has appealed to the U.S. Department of Justice to investigate the case. After the **NAACP** convention in New Orleans, Allen said he will consult with his superiors and their lawyers at the national office in New York, who will also investigate.

"I hope this investigation will prompt Mr. Archie's lawyers to continue to fight, knowning we're willing to go through our national headquarters," Allen said. "For 74 years, the NAACP has taken a stand to protect the civil rights of men. And this office won't stand for this injustice. Las Vegas cannot afford to do this to blacks or to any

Archie is scheduled to be sentenced Aug. 8. He faces a maximum of 35 years in prison.
